Sales Terms and Condition of Sale Agreement

BC Auto Wrecking Ltd. states that this purchase is warranted for a period of 90 days from date of sale unless otherwise stated on invoice. Any defects in this product will be dealt with on a replacement / repair basis. If we cannot replace the defective part(s) or if anticipated repair exceeds original cost then a refund will be issued. Warranty is void if the part has been modified or dis-assembled.

BC Auto Wrecking Ltd. will not assume responsibility for damages, labour costs or any expenses such as towing, emergency road services, lodging, freight or any other related expenses – directly or indirectly at any time.

Returned parts must be accompanied by the original receipt within 30 days. All monies refunded shall be in the same manner as the payment received (ie: cash/ credit/ debit/ cheque)

BC Auto Wrecking Ltd. states that all special order or custom cut parts are not refundable. This includes any parts which were specifically removed in the yard for a sale. Parts returned must be in the same condition as when sold.

All sales under \$50 before taxes are final. No refunds on electrical parts. No exceptions.

Deposits are valid for 30 days. After this period they are non-refundable.

All returns are subject to a 25% re-stocking charge.

Please note:

It is the customer's responsibility to check all parts and accessories prior to install. We recommend that new seals and filters are installed in engines, transmissions, differentials & transaxles. Oil leaks are not covered under our warranty.

Engines are guaranteed to be in good operating condition with reasonable limits of specification. These include: oil pressure, compression, oil consumption & excessive noise. Engines do not include wiring harnesses, throttle bodies, exhaust manifolds, water pumps, etc. Please inspect all of these parts that may have been included before assuming they are useable. Timing belts are not covered under our warranty. No exceptions.

Differentials should be installed with new oil seals. Brake parts are not covered under the warranty and are often stored in the elements deeming them unsafe. Do not try to re-use them.

All drivetrain parts have been drained for inspection & storage. It is the customer's responsibility to reseal and refill each item before putting them into service. These items are final sale & not returnable for any reason. Once they have left the property of BC Auto Wrecking Ltd. they belong to the customer. They are still covered under the 90 day warranty but cannot be returned. Engines, transmissions, transfer cases & differentials are included in this category. No exceptions.

BC Auto Wrecking Ltd. affirmatively states that "used auto parts and merchandise may have safety hazards &/or defects attached to their use whether actual or latent." It is the sole responsibility of the customer to determine if any hazard or other defect exists with the use of any part provided by us through inspection & consultation of an expert prior to installation.
